AFFIDAVIT OF SERVICE

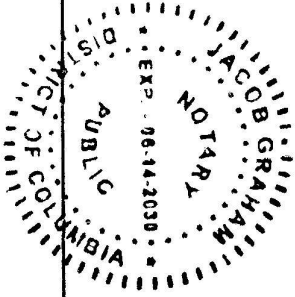
