INCIDENT:

I was dispatched to the station for a harassment report in the lobby.

INVESTIGATION:

Upon arrival, I spoke with [redacted] who stated an unknown subject, only known as [redacted] had made a YouTube video accusing him of [redacted] stated in January of 2023, a YouTube account known as [redacted] began to harass and falsely accuse [redacted] stated he had blocked [redacted] and other chat group applications. [redacted] stated he was made aware of a YouTube video that was posted under the account, [redacted] labeled [redacted] and the YouTube contained videos and images of [redacted] on the video.

[redacted] stated the video is approximately 40 minutes long, accusing him [redacted] [redacted] advised Shelby Township PD Detectives to have interviewed him in the past regarding these allegations which were called in by members of [redacted] according to [redacted]

[redacted] stated concerns regarding possible "swatting" calls due to posting his personal information, such as his personal address and email, [redacted] advised he has received threatening emails recently and blocked the senders. [redacted] stated he attempted contact with YouTube regarding removing the videos from the channel. [redacted] stated he received no help from YouTube regarding the matter.

[redacted] was advised to continue blocking all communication from [redacted] as well as any emails he may receive. [redacted] was also advised to not post any personal information of his in public chats on any application.
