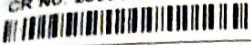

I was briefed on previous contacts with [REDACTED] from Lt. Hogan and Ofc. Nicley. I read previous reports written by Ofc. Nicley referencing [REDACTED] and similar claims [REDACTED]

[REDACTED] Ofc. Nicley and Lt. Hogan informed me that [REDACTED]  
[REDACTED]

Ofc. Nicley and I met at the address and made contact with [REDACTED] was surprised to see police at his door again. I informed [REDACTED] that there has been another anonymous complaint about him [REDACTED]

[REDACTED] gave me consent and allowed me access to his cell phone. I searched through [REDACTED] phone (photographs and apps) and did not locate anything [REDACTED]

I asked [REDACTED] was home. [REDACTED] went inside and brought [REDACTED] outside to speak with Ofc. Nicley and I. I informed [REDACTED] about the complaint and asked if she was familiar with anything [REDACTED] was doing online. [REDACTED] was unaware of anything that he has done recently since the last time the police had spoke with him.



I informed [redacted] that one of the anonymous tipsters stated that [redacted] new DC Schmittler and asked if she knew if [redacted] knew him. [redacted] stated she did not know DC Schmittler and did not know if [redacted] did. I requested [redacted] closely monitor [redacted] online activity due to a previous report stating that [redacted] gave out their address online.

[redacted] spoke up and denied giving out his personal address or phone number, but advised that someone did send him a "wood carving" [redacted] I asked if [redacted] still had that piece of wood and he advised that it was destroyed. [redacted] also advised that he had received phone calls from out of state phone numbers, but made no claims of threats.

I asked [redacted] if he knew DC Schmittler and he stated that a person commented on his YouTube video had the last name of Schmittler. [redacted] did not know of anyone locally with that name.

Ofc. Nicley and I advised [redacted] that we strongly suggested he stay off the internet for awhile. We believed that most of his backlash is coming from him responding negatively to people's comments. If [redacted] wished for the comments to stop, he needed to stop posting online. [redacted] appeared to be receptive to our advice.
