

NOTICE TO CEASE AND DESIST

URGENT LEGAL MATTER — PROMPT ATTENTION REQUIRED

RE: Unlawful Retention, Conversion, and Hostage of Digital Assets Belonging to Vervana Services LLC and Wizards' Den (WizDen)

Dear Pieter-Jan Briers,

This letter constitutes a formal demand that you immediately cease and desist from your unlawful retention, restriction, and conversion of digital assets, infrastructure, and intellectual property belonging collectively to the project known as Wizards' Den (also running under the shorthand "WizDen"), which is legally operated and shielded under the corporate umbrella of Vervana Services LLC (the "Company").

It has come to our attention that you are currently utilizing administrative credentials and access points to hold shared organizational infrastructure hostage, systematically blocking authorized participants from accessing resources intended solely for the operation of the project. Your current actions constitute severe actionable offenses, including but not limited to Civil Theft (Conversion), Breach of Fiduciary Duty and Stewardship, and Tortious Interference with the ongoing operations, community stability, and development of Wizards' Den.

DEMAND FOR IMMEDIATE REMEDIATION

To avoid immediate escalation to formal legal and law enforcement proceedings, you are hereby commanded to strictly comply with the following demands:

- **Cease All Tampering:** Immediately halt any and all attempts to alter, delete, copy, or obfuscate any server data, application files, source code, databases, or configuration files associated with Wizards' Den.
- **Unconditional Turn-Over of Credentials:** Deliver full, unaltered master administrative credentials, root keys, API secrets, and primary access points for all shared servers, domains, and project accounts to an authorized agent of Vervana Services LLC.

- **Relinquish Control:** Completely log out of, disconnect from, and terminate all active sessions on any infrastructure designated for the project, and make no further attempts to access these networks.

NOTICE OF INTENT TO PURSUE LEGAL REMEDIES

You are granted until **Friday, June 12, 2026 at 5:00 PM CST** (the "Deadline") to fully comply with the remediation steps outlined above. Failure to comply by the Deadline will leave Vervana Services LLC with no operational choice but to protect its assets through immediate legal escalation.

The Company is fully prepared to authorize its legal counsel to file an Emergency Injunction or Temporary Restraining Order (TRO) in a court of competent jurisdiction to compel the immediate return of the assets and freeze any accounts under your influence. We will pursue full compensatory and punitive damages for all financial losses, server downtime, and operational disruptions caused by your actions, alongside filing formal reports regarding unauthorized computer access and extortion with state, federal, or international cyber-crimes law enforcement divisions.

Please be advised that your personal liability in this matter is substantial. This letter serves as your formal notice to preserve all communications, logs, code repositories, and financial records relevant to Wizards' Den, as they are subject to strict data preservation rules and discovery during litigation. Govern yourself accordingly.
