Recently, accusations have been cast against MGC, Sensei, and its Moderation Team, so we decided to write this document and provide our side of the story to calm the waters.

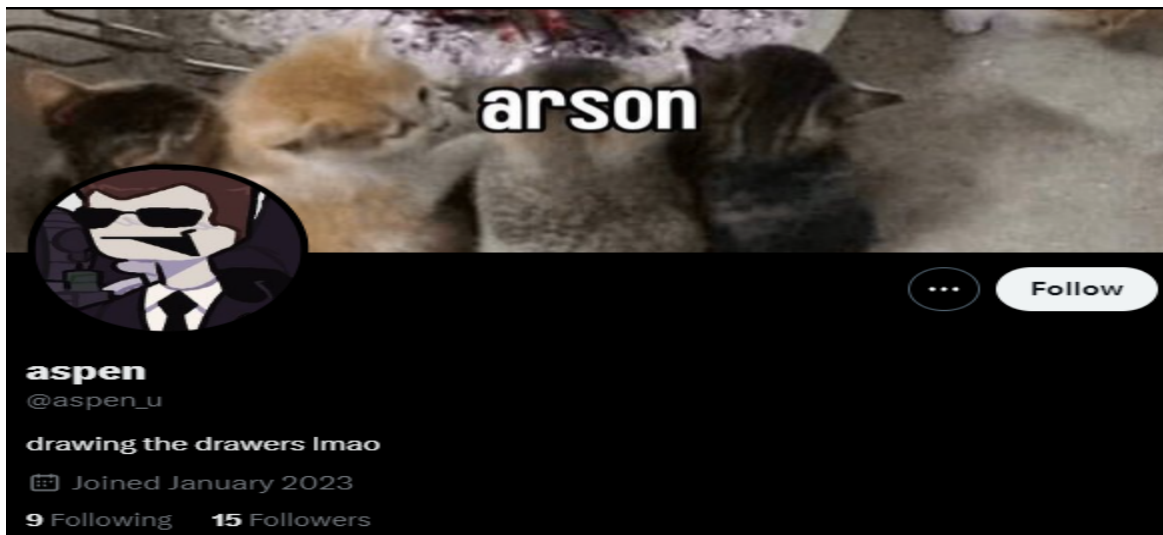
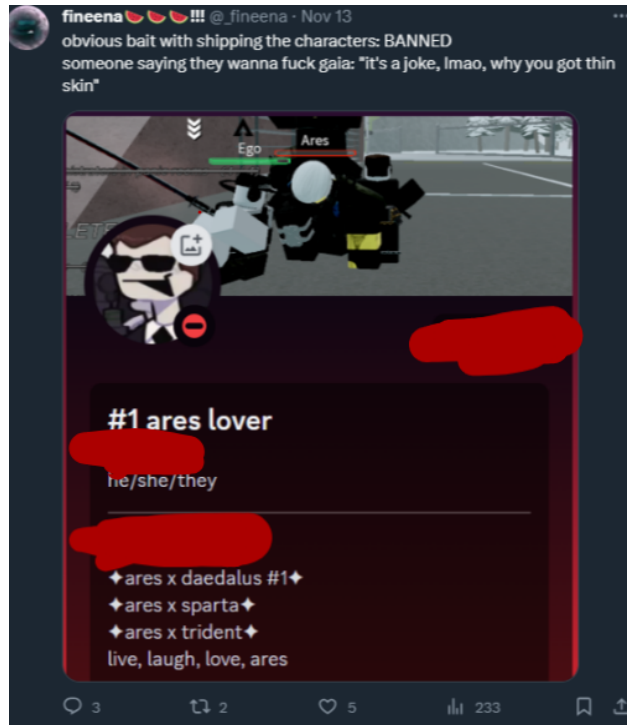
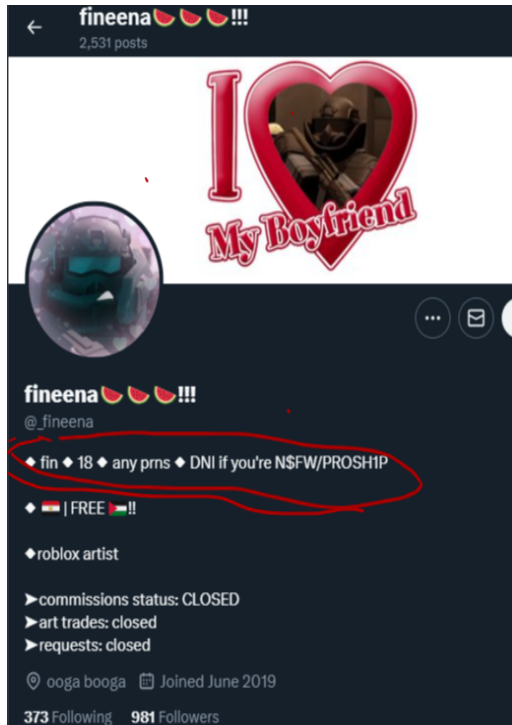
Section 1: Clarifications

To begin, **We are minors**. Much of the server and all of the moderation team are under 18 (which we're certain is the universally agreed standard of adult age). The policies we take in Migato Creations are to protect said minors from exposure to the terribleness the internet can produce. We value this policy deeply because many of us were exposed to the internet at a young age. There are several cases of moderators banning Discord users under 13 with the firm request to stay off the internet to enforce a safe environment as well as to protect people even outside of our server limits, as we are doing here. This is the bare minimum standard of human behavior in ANY server. The Moderators involved with this situation are all in the age range of 14-17 years old.

Section 2: The People Behind the Campaign

The user going by the handle “@_fineena” or “@aspen_u” (*who at the time of writing this is confirmed to be 18. Aspen_u most likely a burner account*) has made the “MiGato Creations callout” Twitter thread. ([tweet link](#)). Given the situation and evidence, we will address these allegations head-on.

Evidence of the burner account being linked to @_fineena:



In the images provided, it is shown @aspen_u has the exact same profile picture as the Discord account profile posted by @fineena. This is strong evidence inferring that this account is indeed a **burner** account. We have taken the liberty of censoring the username of the Discord account in question to maintain privacy.

In the rules, it is strictly stated:

Fanart Rules:

All of these are a bannable offense and will not be tolerated.

- No shipping / romance between characters
- No gender-bending characters
 - This means to swap the sex of a character
- No crossdressing
- No fetishizing characters
 - This includes cat ears, and lingerie

These rules have not been updated for years. Even in the previous editions of the rules, it is clearly stated that shipping and romance between characters is strictly prohibited. Whether you agree with these rules or not, they should be respected within the bounds of the server.

This person – presumably out of spite – began a campaign with their friends and other followers of slandering MiGato Creations’ (and to a lesser extent, Sensei_Developer’s) reputation, although this is purely speculation. There’s good reason to believe this, however. The people in question have historically had a testy relationship with the Discord server and its staff, so it does not leave out the possibility of their involvement.

Should this speculation be confirmed (to which we’re very confident), it would immediately discredit their campaign of slander. These users are the same users responsible for drawing **fetishized** or **romanticized** characters of Dummies vs Noobs IP’s, then calling out the staff of MiGato Creations for ‘inappropriate behavior’ upon taking action.



These users are grasping at straws, attempting to gain any leverage possible. At the time of writing this, Fineena posted the provided tweet when a user who participated in the “cyberstalk” was given a joke role by one of the Moderators for discussing the drama in public areas.

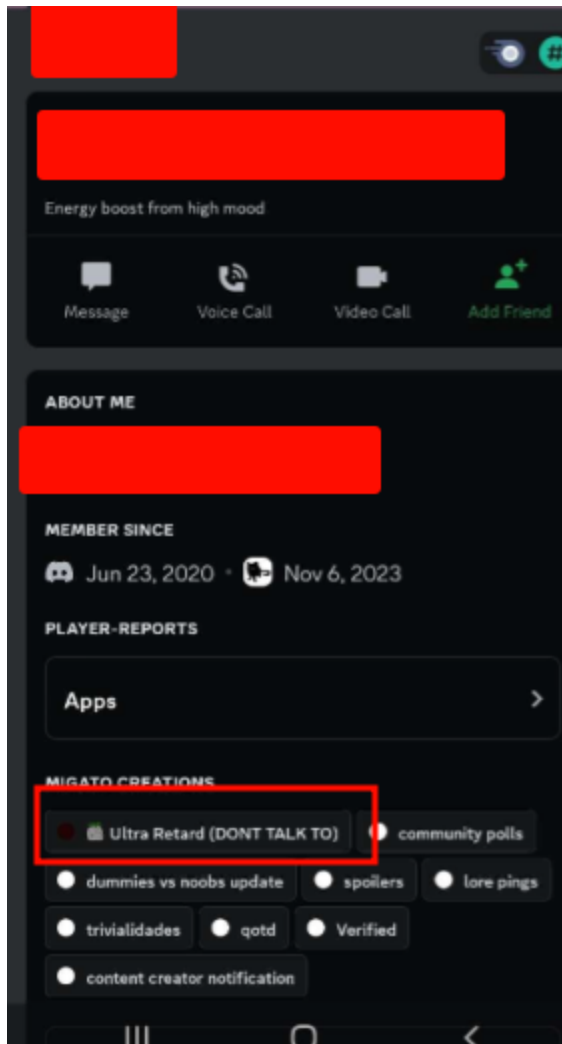

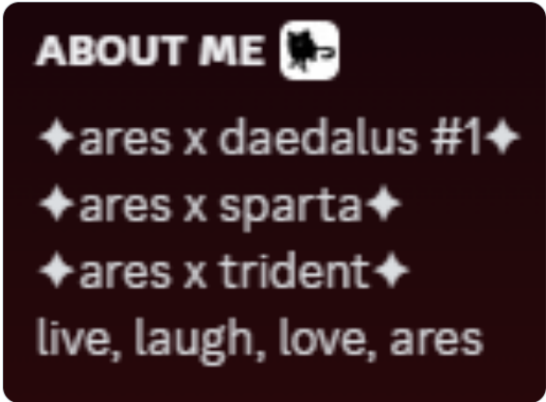
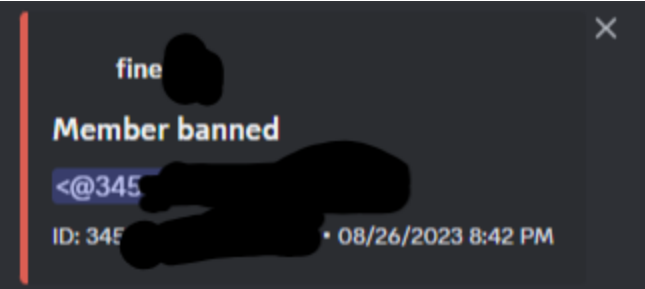

Section 3: "Bait" Ships vs. Gaia Cases

In the MiGato Creations culture, it is extremely frowned upon to **sexualize Gaia** as she is a minor (17 years old). The same goes for any of the bosses and units seen ingame. The people who do this are typically dealt with quickly and efficiently by the moderators, without question.

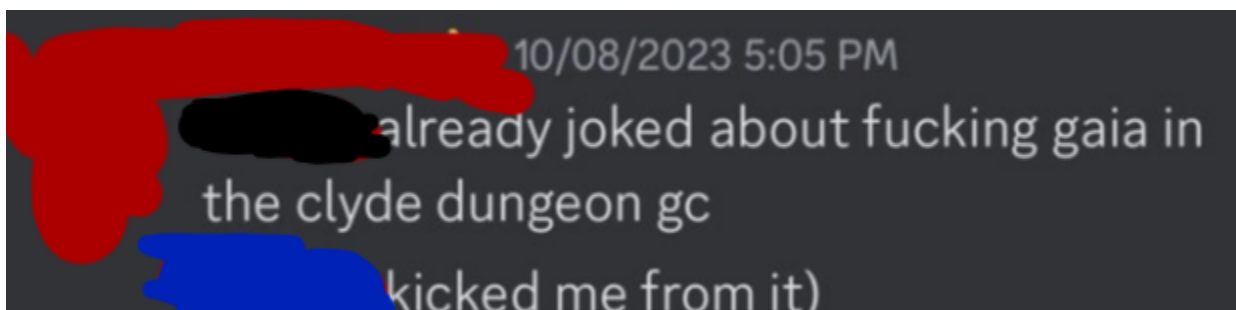
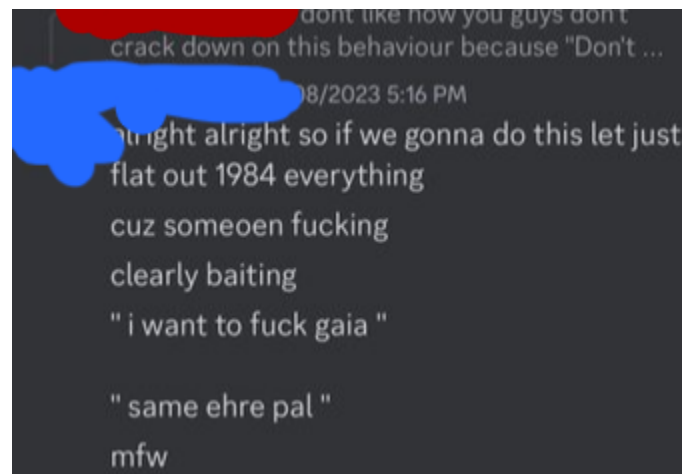
One of the cases brought up in this thread calls out a moderator for not properly punishing those who make sexual remarks about Dummies vs Noobs characters. They cited a certain server member, who has since come out and stated the true nature of those statements.

In conclusion to this section: This person, even while saying these remarks in a joking manner, did not receive proper punishment. In a conversation one of our moderators had with said person, it is revealed that it was indeed done in a joking manner. This is the fault of our moderation team and we do take ownership for our mistake for not properly handling this situation.

However, this one instance should not automatically spoil the rest of the batch. Do not draw conclusions too quickly.

Section 4: Failure to Report Misconduct

There are **3** ways to contact our staff team:

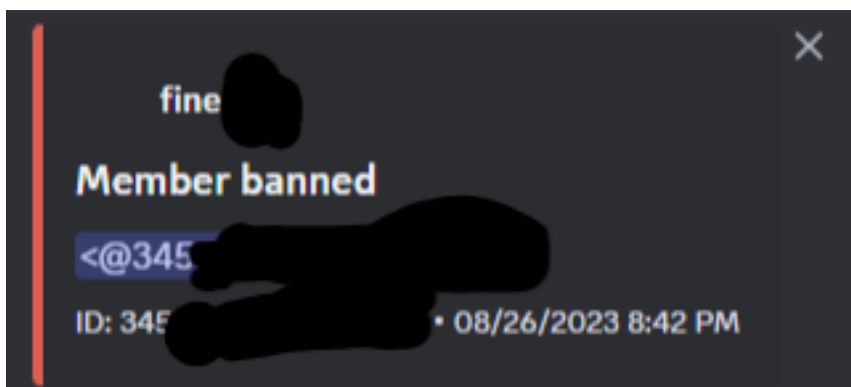
1. Staff DM's
2. Ticket reports
3. Appeal server

These allegations were made accusing MiGato Creations of 'promoting cyberstalking', despite the fact these users have *never* made an attempt to contact the staff team so that this behavior could be properly punished. By not reporting these issues and collecting these misconducts over the months (as well as the disrespectful/derogatory language of the tweets), this is yet more evidence for a deliberate campaign of **slandering**. While yes, they were banned, that doesn't immediately rule out the possibility of contacting these moderators through someone else in the server, or DMing the Migato Creations twitter account.

Section 5: @_fineena and Related Accounts

We have banned these users for violating fan-art rules. Plain and simple.

Their behavior on the server was testable at best, as they were always up to no good. They would often be seen talking in a sexualized manner and constantly **promoting/discussing the active consumption of pornography around minors**. It should be obvious now that this behavior is not tolerated in MiGato Creations thus why they were banned.





For clarification, 'Yaoi' refers to pornographic material involving men. Some of these people could be minors. Additionally, the user 'pt558pt' (display name: 'sera') was also banned from MiGato Creations under similar pretenses.

These tweets were deleted shortly after.

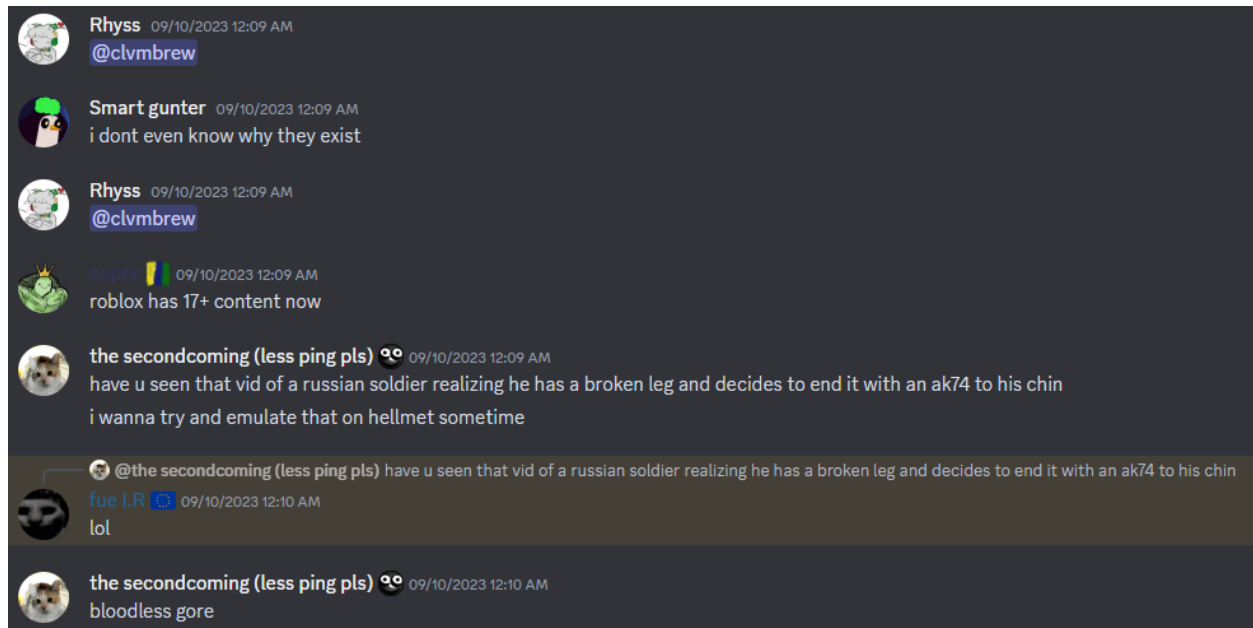
Section 6: The Owner

Sensei_Developer at the time of writing this document is 16 years old, having only turned 16 a month ago. When Dummies vs Noobs first got popular, he was 14. He then had to manage a community and moderation team when he was 15. Naturally, as a younger man he had a tendency to overshare.

These events happened because he was young and naive, and did not yet know how to properly manage a community. He has long since moved past his old immaturity and is actively trying to improve his behavior. This is well-defined in his old tendency to watch videos and clips from the ongoing war in Ukraine. His tendency to overshare made users uncomfortable, and eventually Sensei_Developer noticed (or by someone else asking him to stop) and began the process of healing.

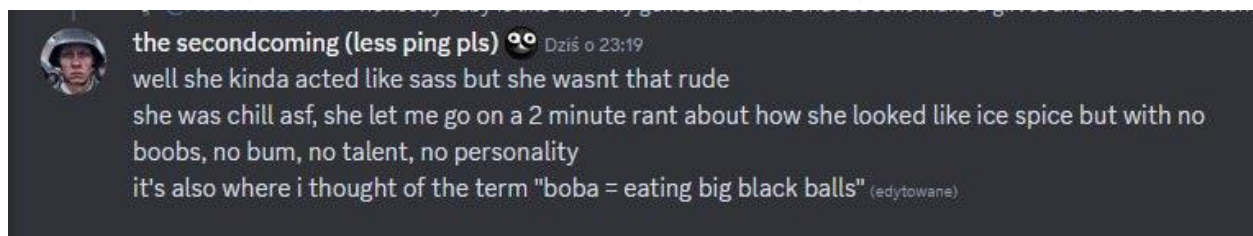
Adding onto the accusations of gore in the server – this is simply not true. Sensei_Developer has never once posted gore and has only discussed it (again, in the past). The most recent discussion of it was under the context of new features for the next MiGato Creations installment, HELLMET. HELLMET is a

game aiming for smooth gameplay and realism, and naturally that includes gorey deaths. Gore is also a natural part of Dummies vs Noobs, and can be toggled off in the settings.

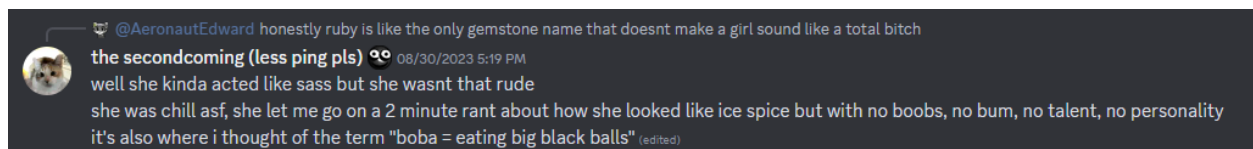


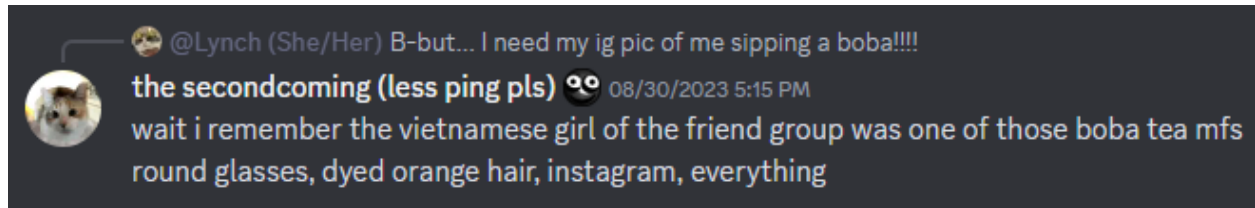
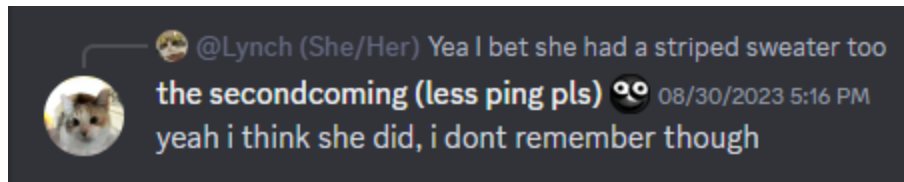
(again, the screenshots the users used to slander his name were severely out of context and serves as more evidence of ill intention.)

These screenshots were in the context of Sensei_Developer recalling one of his experiences where he went out with a group of friends. In fact, according to his testimony, the woman in question who received these comments was done with her full consent and approval. Additionally, these ‘violations’ were not violations of the rules against sex-talk, as the rule states in its definition:

- *Excessive* NSFW discussion.

<- “*Excessive*” is italicized.

If you want to criticize Sensei_Developer, whether for his behavior or his games, he is always open. He will never shut down criticism, as long as it is constructive and well-intentioned. Please do not go out of your way to start drama over something that could be solved by a simple DM.

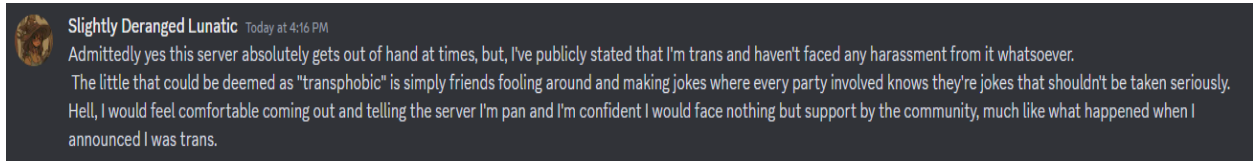
Section 7: Transphobia

In the call-out thread, it is claimed multiple times that MiGato Creations was fostering an environment for transphobia. This is blatantly false.

Several notable and well-respected members hold beliefs against transgenderism, but they don’t actively go out of their way to threaten, harm, harass, or hurt anyone who’s part of the transgender community. Ironically, it’s very common to see those who are against transgenderism being friends with transgender people in this server. It’s perfectly OK to hold differing beliefs, as

everyone is entitled to their own opinion and should be in an environment where they should freely speak their mind.

In fact, one of our moderators is transgender herself and has come out with the following statement:

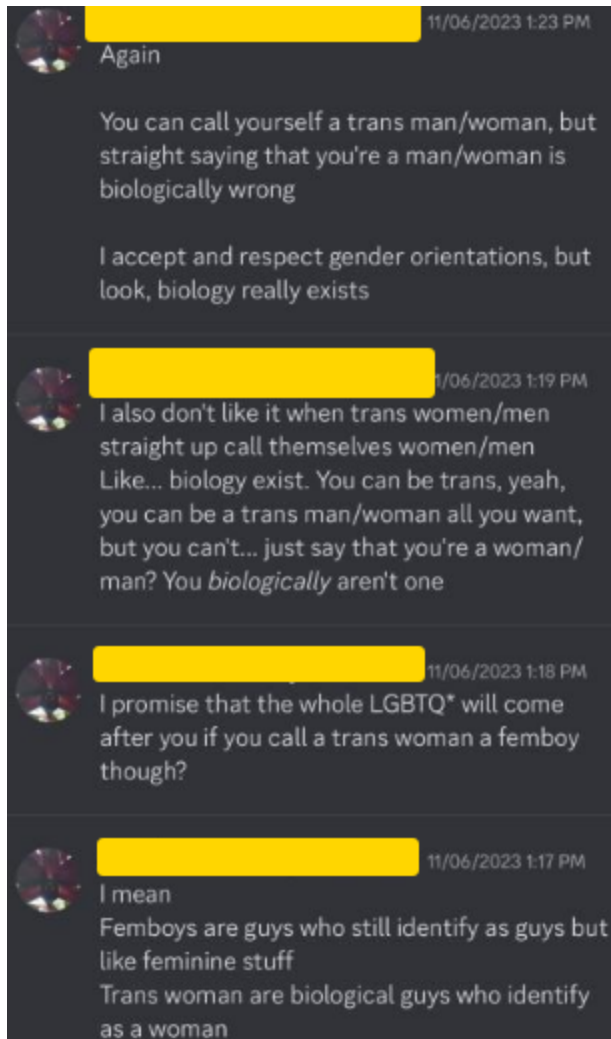

Nobody had persecuted her or gone on a spree of hostility against her. She felt welcome and safe in MiGato Creations, even if some members held differing beliefs. MiGato Creations is home to LGBTQ+ members and those against it. So long as they do not violate rules and make users uncomfortable, they are accepted and belonging regardless of political stance or involvement.

We don't want to be political, but the circumstances of this situation require some logic. We don't want to become an echo-chamber, and while you may agree on some topics, others may disagree. We do not want to shunt out the other side, so as a result we do not punish those who may hold differing beliefs (so long as it isn't actively hostile or threatening).

Adding on with one last thing. In the thread, the user claims the server is transphobic while showing the following screenshots of a certain user making remarks and comments about transgenderism:



The user tries to paint this specific server member as the entire server being transphobic. I believe the problem in this argument is self-explanatory as this is only one person's opinions, and even then she respects transgender people and uses their proper pronouns. We won't debate the political theories behind transgender people. This should be obvious. Some of these statements that were not posted were under the context of Sensei_Developer mistaking them for a trans woman, when in fact she was a biological woman.

Section 8: Accusations of Cyberstalking

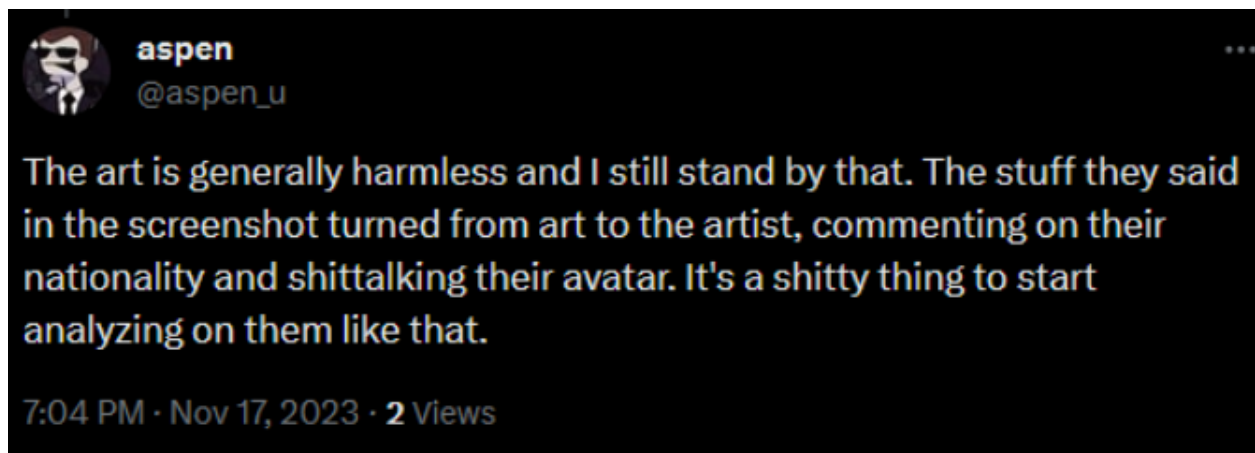
The person in question – Zombie – claims to have been cyberstalked. The 'Cyberstalking' were simply people attempting to find her ROBLOX account, as people who violate fan-art rules are also eligible for an in-game ban

as well. **This is not cyberstalking. This did not continue for any more than one day**, and *afterwards everyone simply forgot about the incident*. This ‘cyberstalking’ did not directly endanger the person’s personal info, nor their identity, nor anything that could potentially threaten their safety.

Zombie is an artist known for making ship-art (despite being a minor) and drew ship-art in MiGato Creations, which as discussed countless times is a **bannable offense**. Whether you agree with our rules or not, they should be obeyed under the pursuit of positive intention, ESPECIALLY when minors are involved.

However, we are indeed at fault. We allowed this form of harassment to succeed under the radar and it is our duty to try and stop these. In order to know about these incidents, we must know about it in the first place, which is why we have a report system in place. We had no record of this person attempting to contact the moderation team to stop this, even if she was banned. That does not excuse us however, though it does shed light onto the issue.

Section 9: The Art



The opposition defends the art with the logic that it is “harmless”. From a developer’s perspective, seeing art like this made for your game is very hurtful

(cited from fandoms such as Undertale, a game infamous for its disgusting art that the developer must witness).

Again, we do not discriminate against ANY class. We have a vast amount of members in MiGato Creations, of which assume different political parties. The art that was created is factually **fetish art**, cited from the fact that the majority of the internet *agrees* that transgender art is weird, in which the ethicality is often questioned (solidifying the point as to why we made those rules in the first place).

It's easy to say "the art is innocent" but it is difficult to argue "the art is innocent because...", especially in a situation involving minors viewing the art as well as **minors in the art itself**.

Section 10: Motivations

And to those who were responsible, who may now be reading this document. *Why? What do you gain out of this?* The following is speculation, and should not be taken as a hard concrete accusation.

Given the evidence provided, there's good reason to believe there is some malicious intent behind the propagation of this slander. Partially, we believe it may be done out of spite (refer to previous sections). However, it should not be ruled out that these people *may potentially be using this as a form of attention generation for their own twitter pages*.

The person who made this thread, @_fineena, claims to be an adult. This person put heavy emphasis on the fact that Zombie is a minor, using strong language like cyberstalking. If Zombie is a minor, and is being actively cyberstalked, why would one include the name in the tweet? The internet can be a terrible place, and given its place in a public 'call-out thread', it's safe to assume people on the internet can still have ill intentions and target other people regardless.

To add onto this chain of speculation, Zombie recently changed her twitter display handle to include "(MGC DOWNFALL LETS GO LMAOO)", which is not something a 'cyberstalking victim' would go out of their way to put in their bio. It's

due to this that we believe this has been done as a way to gain publicity and attention to the artists pages, while also flaming the opposition for a ban that was completely justified.

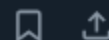

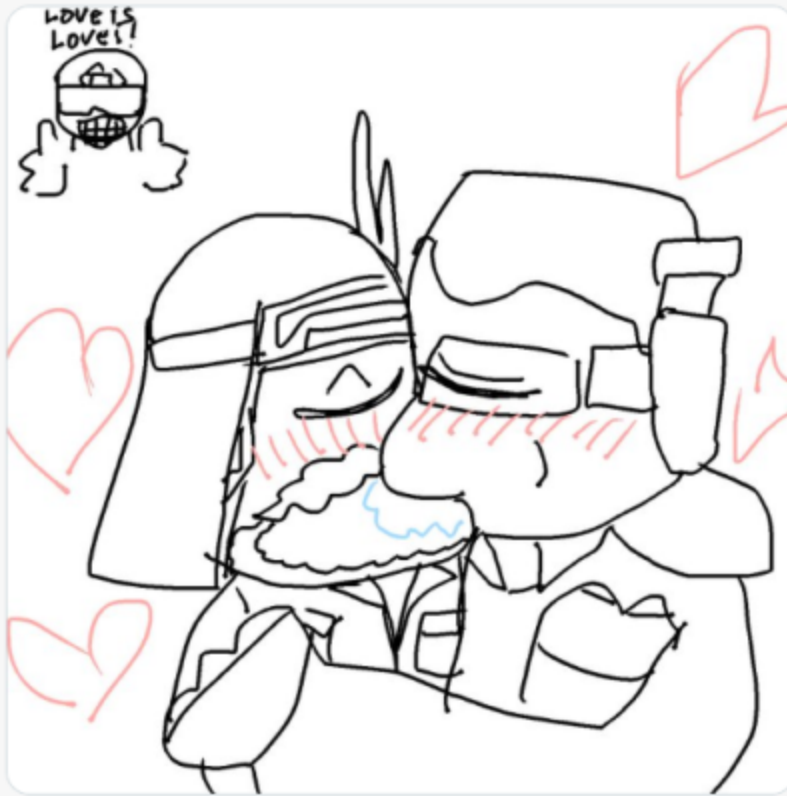

Section 11: Steps Towards Reform

Although we have had faults of our own, it does not naturally conclude that the cases of rule violations do not go unpunished. Many of the claims and accusations were done completely out of context and those that were in context still fit within the rules, while those that broke the rules have been punished accordingly.

In addition, our Moderators have concluded that revising rules and correcting inappropriate behavior within the community itself is needed in order to assure that this incident or similar does not occur.

This is a deliberate campaign of slander. The people who are spreading these only wish to propagate negativity and do not have your best interests in mind.

This document was not written by Sensei, this was written by the Moderation Team.
