

LETTER TO THE COURT

To: Justice of the Supreme Court, Queens County

Re: *Trueman v. Zhen* | Index No. 703276/2026

Relief Requested: EMERGENCY 45-DAY STAY & INTERIM ORDER TO SEAL RECORDS

TO THE HONORABLE COURT:

The undersigned *pro se* litigant respectfully submits this correspondence to report an active, real-time security crisis involving the NYSCEF docket and the **discharge of counsel for cause** following a repeated pattern of professional abandonment.

I. DISCHARGE OF COUNSEL FOR GROSS NEGLIGENCE (2025–2026) I have discharged **Jasmine Aiken, Esq.** for cause. This decision follows a history of abandonment, beginning **December 23, 2025**, when counsel failed to be proactive for a critical proceeding, she could not be found, and I ended up representing myself, Pro Se. Most recently, Ms. Aiken was retained to handle this Supreme Court action and an imminent eviction crisis. Despite the high stakes, she filed defective papers on January 21, 2026 (marked "**Returned for Correction**"), and failed to remedy them before the **February 9, 2026** deadline. Her office remained silent until **4:21 PM today**, requesting further delays for a "fee inquiry" while my family remained legally and physically exposed. I am attaching correspondence today from her with this letter, along with my response.

II. CRIMINAL EXPLOITATION OF DOCKET AND JUDICIAL INTEGRITY Malicious third-party agitators on platforms including **Reddit, Kiwifarms.st, Lolcow.farm, YouTube, but not limited too**, are currently utilizing this Court's records as a tool for criminal harassment. This conduct falls outside the protections of "fair use" or "protected speech":

- **Surveillance Timeline:** As an example, today, beginning at **12:22 PM EST**, these actors began scraping the docket to track my family's movements. By **4:20 PM EST**, direct links to this file were distributed to facilitate real-time "live-stalking" and screenshots of handwritten papers by me with my signature were distributed for review of these people.
- **Targeting of Judicial Identity:** These actors have misappropriated the **Judiciary Seal** and the **Judge's holographic signature** for commercial profit and to mock the Court's authority, plastering this all over Reddit, YouTube, Kiwifarms, Lolcow.Farm, etc..
- **Physical Peril:** This "surveillance roadmap" has led to photographs of my residence, non-stop photos, intermittently, with photos of how to get to my street, photos of my car, etc. being published alongside threats of death and sexual violence.

III. PENDING HEARING & NECESSITY OF THE "GOLD SEAL" A hearing is currently slated for **March 2, 2026, before the Hon. Ira Greenberg**. I am manually filing an **Emergency Motion**

to Seal by the end of this week to obtain an **Exemplified Order under the Court's Gold Seal**. This motion is a matter of life and death, as it seeks to protect the litigants from a decade-long campaign of **aggravated harassment, physical trespassing, bounty on Jane Doe's head, physical threats being placed in YouTube videos, Reddit posts, Discord servers, X, and other places, vehicle vandalism, and documented "swatting" attempts by the police**. The motion will move to protect the integrity of the March 2, 2026 proceedings by **strictly prohibiting all audio-visual coverage, streaming, or recording** by third parties who seek to monetize Jane Doe's private trauma and facilitate further physical violence.

IV. CONCLUSION To ensure these parties are dealt with appropriately and to prevent further irreparable harm, I respectfully request an **immediate 45-day stay** to retain new counsel and an **emergency interim Order to Seal** these records to protect the Court's officers and my family.
