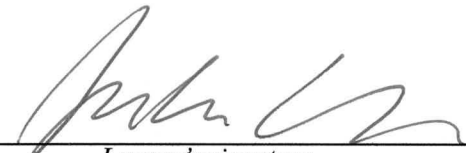

I am Isabella Montagna and I am the Petitioner in this action. I bring this Petition because I fear for my life and safety. I am a 19 year-old art student at Otis College of Art and Design. Beginning in November 2021, Respondent Muudea Sedik ("Respondent") sexually assaulted me on multiple occasions, and over the last several weeks, he has made private and public threats to my life, repeatedly harassing me online and by phone. Respondent also pulled a gun on me, which is captured on video (Ex. C). I believe that Respondent is severely mentally ill and unstable. I fear that he is going to harm me.

I met Respondent online in October 2021, shortly after I turned 18 years old. Respondent is a famous YouTube video creator (professionally known as "TwoMad") with millions of subscribers and hundreds of thousands of followers on Twitter and other social media platforms. On or around November 21, 2021, Respondent invited me over to his house to spend time together. When I arrived at his door, he immediately asked me for my ID to verify that I was 18 years old. He then asked me to give him my phone, which I did. He then deleted our prior text message conversations my phone, and told me to leave. I immediately felt very uncomfortable and left after just ten minutes.

In December 2021, Respondent manipulated me into coming back to his house to visit. He ensured me that he would not make any sexual advances towards me, and that he simply wanted to apologize to me for how he had previously acted. He gave me marijuana, and I quickly became intoxicated. He then returned to making sexual advances. As we were watching a YouTube video together, he pulled out his penis and demanded that I give him oral sex. I was in shock and refused him over and over again. At that point, he placed himself between me and the door and began to get enraged. I knew he had multiple guns in the house, and he was not going to let me leave. Because I was scared of what he would do to me if I continued to refuse his advances, I performed oral sex on him against my will. I was too intoxicated to drive home that night.

His manipulation continued over the next several weeks, and he exerted sexual control over me, eventually coercing me to have sex with him against my will. I repeatedly told him that I was not consenting to sexual relations with him, and in an attempt to lure me back to his house again, he sent me a photograph of a "contract" he drafted wherein he promised not to demand sexual acts from me, and he acknowledges his "wild uncontrollable psychological problems." A true and correct copy of the photograph is attached hereto as Exhibit A

By January 2022, I had had enough. I told Respondent that I would never allow him to touch me again. As I turned to run out of his house, he ran after me, tried to tackle me, and he groped my breasts. He seemed to find this funny. I was in tears and begging him to let me leave. When I finally got out of the front door, two of Respondent's friends happened to pull into the driveway. They saw my highly emotional state, and they asked me if I was okay. I told them that I was not okay, and his friends acknowledged that Respondent was known to act this way toward women. At the time, I did not go to the police for fear of him retaliating against me. Shortly thereafter, Respondent sent me a video of him apologizing for sexually assaulting me. The video will be provided to the Court at the evidentiary hearing.

Over the last several months, Respondent has continuously harassed and stalked me, making several threats to my safety. Respondent's threats and harassment have become more and more alarming over the past two weeks. In the past, he has showed up to my apartment unannounced, and as recently as four days ago, under information and belief, he sent a package to my parents' address in Orange County, CA.

While I blocked his phone number, he set up eight "burner" phone numbers so that he could continue to spam me, contact me, and threaten me. The text and spam messages number in the thousands. In one unsolicited direct message, he threatened: "School shooters are like tortured souls that fester in dark rooms with their misery...is there a chance hmmm yeah...like I might get a phone call from Jesus Christ to exhume your soul for the sacrifice and unfortunately in that situation I must do."

Further, Respondent repeatedly harasses and threatens me online, including on Twitter, which has provoked his large following of fans to join in in the harassment. Just a few days ago, Respondent referred to me in a threatening tweet: "Watching Death Note to mentally prepare on most effective way to make this bitch jump out of her skin in her apartment." In another tweet, while talking about me, Respondent posted a meme, depicting three assault rifles, with the caption "Who's getting the assault rifle." He further tweeted that he will "burn [my] life to the ground" and that he is "plotting on the bitch." In another tweet, he bragged about sexually assaulting me: "What do you mean I got a bunch of head and sex from her I won lol." He continued: "Well actually it's around 30 when art students become successful they kinda die inside in the meantime ima get away with this shit."

After being confronted online for sexually assaulting me, he tweeted to his hundreds of thousands of followers: "YOU KNOW WHAT, I WOULD DO IT AGAIN." In another tweet, he posted a video of two birds mating, with the caption, "so this is what I did to Bella basically." Respondent continues to post photos of me in connection with threats to my safety. Examples of Respondent's online and telephone harassment are attached hereto as Exhibit B.

Further, Respondent is in possession of multiple firearms, and his online harassment makes reference to his firearms. In between his threatening tweets, Respondent posted a video of him firing his gun off in on his patio at his home. Respondent is known for flaunting his significant arsenal of weapons online, and he appears to have a fascination with firearms. On one occasion, Respondent pulled a gun on me while I was standing at his front door. The act was photographed on his doorbell camera, and he posted the photo to his Twitter account. True and correct copies of Respondent's gun-related activity is attached as Exhibit C.

Fearing for my life, on or around June 26, 2023, I went to the Culver City Police Station and filed a police report (Case No. 23-3383). Officer Beau Railsbach suggested that I immediately hire counsel and seek a civil harassment restraining order.

I am terrified that Respondent is going to kill me and/or continue to attempt to exert sexual control over me. Respondent appears to be severely mentally ill and unpredictable. The constant threats and harassment are ongoing, and Respondent has caused me substantial psychological and physical harm. His conduct has led to my extreme anxiety, depression, and habits of self-harm.

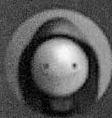
For the next 60 days, Under all facets of interaction with Bella online or in-person, Muudea agrees to:

- Muudea will not demand, entertain, sexual activity with Bella.
- Muudea will be required due to his history demonstrating wild uncontrollable psychological problems and disregard to other people around him, to be hyperaware that he is prone to easily scaring, emotionally damaging, bella.
- Bella may use the word "Facade", when this word is used Muudea will be required to slowly, gently, earnestly process as to how he's wronging, scaring, hurting bella with his behavior, refuses to process, if he cannot understand, deflects, lies, to not understand and change to bella's satisfaction, muudea must concede peacefully and the exit clause is executed.
- Muudea cannot lapse on any part of this agreement, any exception at all will execute the exit clause.

Exit Clause: Bella can exit this agreement at any time, Bella agrees she will not exit this agreement unless she has made a full analysis of our relationship and is completely sure that her wellbeing is contingent on me not interacting with her at all, that she does not want anymore time spent hearing from me, Muudea agrees to move on with his life.
